Subject: Onboarding and Integration of all management type of schools including Private Schools to Vidya Samiksha Kendra (VSK) in States/UTs – Reg.

The Vidya Samiksha Kendra is envisioned as a "force-multiplier" in the Indian Education system that aims to bring visibility to near real time educational datasets and enable data driven decision making for all educational stakeholders. It is encouraging to know that so far, 33 States/UTs and 3 Central Autonomous Bodies (CABs) have operationalized their VSKs and 30 VSKs are connected to the Rashtriya Vidya Samiksha Kendra (RVSK) at CIET-NCERT. As we are nearing the milestone of setting up digital educational infrastructure across the country and enabling its seamless integration with each other and RVSK, I would like to bring your attention once again to an important component as previously highlighted in the letter from Secretary, DoSE&L dated 15th July 2024 (attached for reference) that kindly onboard private schools on VSK platform.

The Vidya Samiksha Kendra is established in the State/UT for the benefit and utilization of all students, teachers, and principals in the State/UT. It is understood that some of the States/UTs VSKs are only capturing and analysing data from Government and Government Aided schools currently. It is important to understand that the utility and benefits of VSK as an infrastructure and platform is not limited only to Govt./Govt. Aided schools, but to all stakeholders (Students, Teachers, Principals) enrolled in different management types of schools including private schools with a valid UDISE+ ID.

For your ready reference, some of the key provisions from the Right to Education Act (2009) and National Education Policy 2020, which emphasizes on the importance of including all schools in various provisions of the government schemes are provided below:

Section 12(3) – "Every school shall provide such information as may be required by the appropriate Government or the local authority, as the case may be."
